Entrants are judged as two year olds, but must be nominated before they are born.

There are three payments:

1st Payment: Nominating the Mare before the foal is born.

Entries close on July 31st and are only accepted for Mares covered between August 1st the previous year, and that date.

2nd Payment: Due by July 31st before the foal is a yearling

3rd Payment: Due by July 31st before the yearling is a 2yr old.

Current Foal Futurity Fees: Payment 1 - \$5.00 Payment 2 - \$10.00 Payment 3 - \$20.00
